# **Foundation Financials** Tom Scott, Treasurer

St. Luke's Foundation has not been immune to the volatility of the financial As of June 30, 2022 the markets. Foundation experienced a decline in invested assets market value of \$159,340 (\$1,044,095 to \$844,750). This 15% decline, while significant, compares well to the S&P 500 year to date decline that currently sits at negative 20.23%. St. Luke's Foundation exceeded the broader market based in part on the recent diversification of the portfolio. Underperforming bonds were reduced and replaced by alternative investments better able to withstand the overall market volatility. These alternatives, generally available only to larger accounts, focus on high value corporate bricks & mortar assets. In addition to these investment changes, consistent with the Council's approved investment policies,

the Foundation Committee has taken a very conservative non-panic approach to our current holdings. Accumulating cash is being held in reserve ready for investment as the markets begin to rationalize themselves. The Foundation maintains market rate accounts in local banking facilities held primarily for near term use requirements. These accounts enable the Foundation to respond to cash needs without necessitating a market sale.

# Foundation Grant Aids Stephen Ministry

The Foundation Committee received a grant request to provide funds for Steve Luecke to attend the Stephen Ministry Leadership Training Program. request was approved by the Foundation Committee. Upon completion of the program, Steve along with his co-leaders Ruth Fruehling and Maureen Oostdik were able to recruit two additional St. Luke's members, Lea Cornell and Donald St. Pierre, as future Stephen Ministry leaders. A second grant request was sent to the Foundation Committee and funds were approved for them to attend the Stephen Ministry Leadership Training Program, which they are presently completing.

These five will be working together as a leadership team to train future St. Luke's Stephen Ministers. The goal is to train

10-15 Stephen Ministers, who will minister and care for people who are hurting, confused, mourning, and those lost from God's love. Over the history of the Stephen Ministry program the primary users have been the older age group, but Stephen Ministry can assist, support and work with all age groups--both younger and older.

Steve indicated that thanks to the Foundation for providing funds for training and updated materials, the Stephen Ministry leaders will be able to kick-start and invigorate the Stephen Ministry program at St. Luke's.

Steve stated that this is an exciting time as St. Luke's expands in-person ministry overall and a revitalized Stephen Ministry will enhance care for hurting people both inside the congregation and from our broader community. Stephen Ministry is truly central to the purpose of St. Luke's to "Connect, Serve, and Grow in Christ's Love".
